

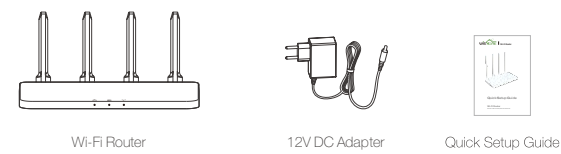

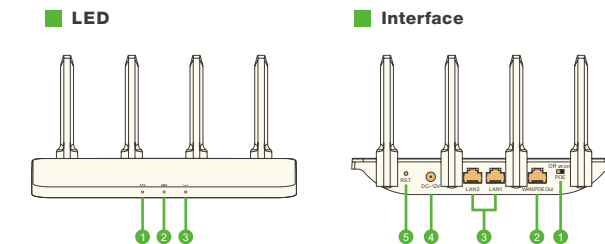

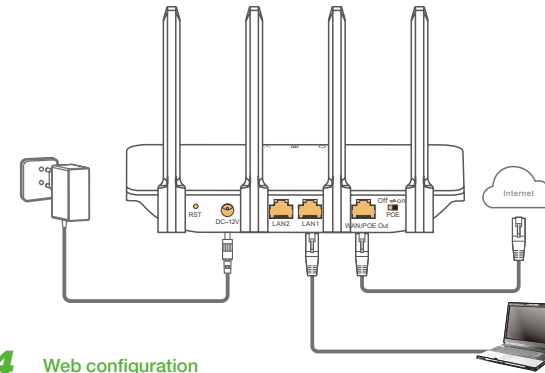

3 Install the radio

Internet configuration method used as a single router

After the router is powered on, the power indicator light is green. After 90 seconds, the system is successfully started, and the WiFi light is green.



4 Web configuration

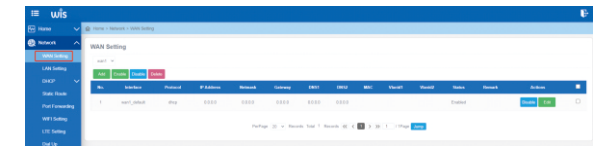
1. Check all wires are correctly connected.
2. Configure the host system dynamic IP to get the IP from the router.
3. Using a web browser access 192.168.2.1 (wait a few seconds after device power up).
4. When login page appears enter "admin" in both the username and password fields.

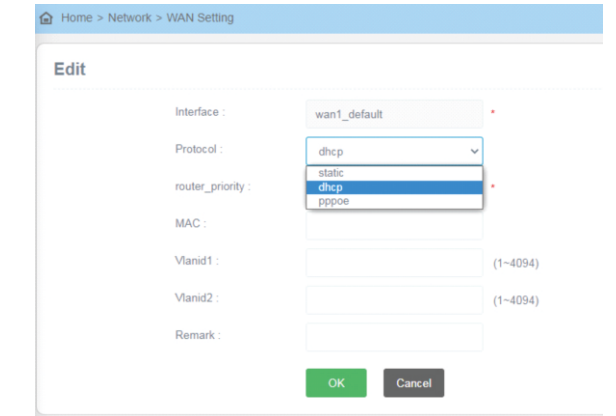

Internet via WAN PORT

1. Connect the **WAN** port of the device to the **Internet** with a network cable, and connect the **LAN** port of the device to the computer.
2. Power on the device and login to the device management Web-page.



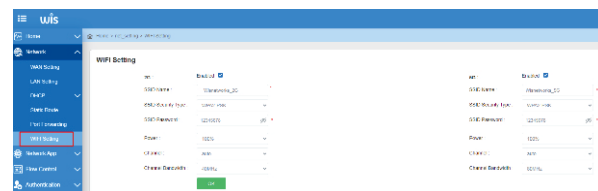
3. Click **WAN Setting**, click **Edit** to configure the **WAN** port parameters. (The default is **DHCP**)
