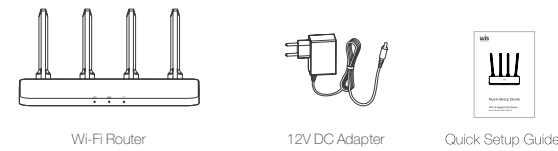

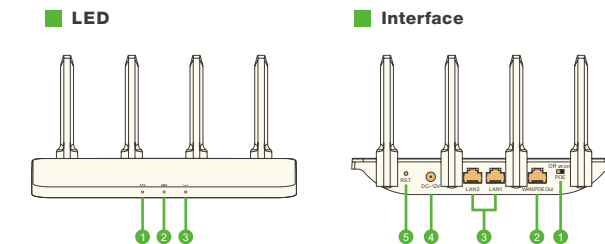

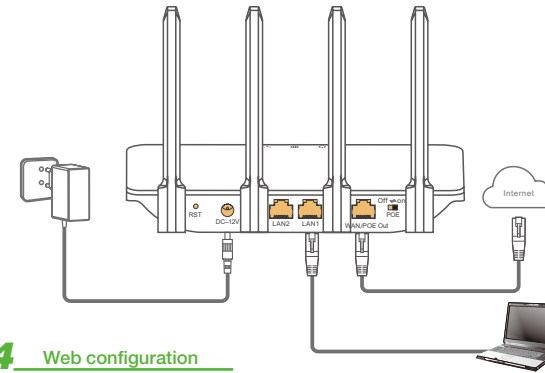

## 3 Install the radio

### Internet configuration method used as a single router

When the router is powered on, the power indicator light is green. After 120 seconds, the system is successfully started, and the WiFi light is green.



## 4 Web configuration

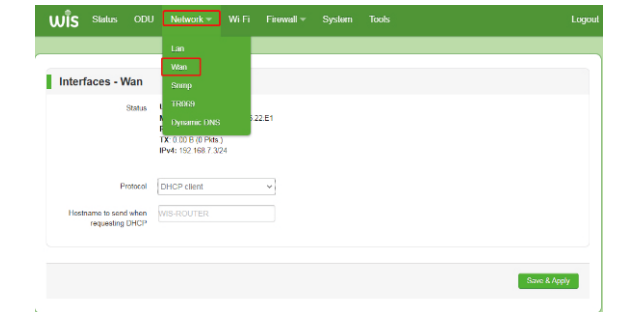
- Check all wires are correctly connected.
- Configure the host system dynamic IP to get the IP from the router.
- Using a web browser access **192.168.2.1** (wait a few seconds after device power up).
- When login page appears enter **"admin"** in both the username and password fields.

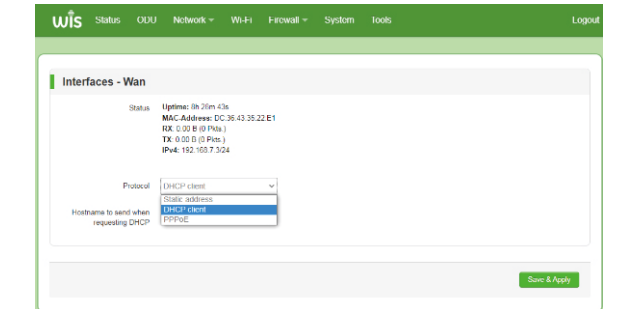
**ATTENTION**  
Shielded Category 5 (or above) cabling should be used for all wired Ethernet connections.

## Internet via WAN PORT

- Connect the **WAN** port of the device to the **Internet** with a network cable, and connect the **LAN** port of the device to the computer.
- Power on the device and login to the device management Web-page.



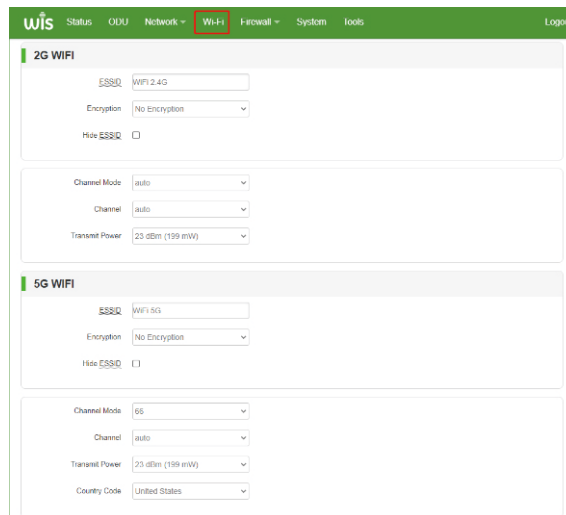
- Click **Network**, click **WAN** to configure the **WAN** port parameters. (The default is **DHCP**)



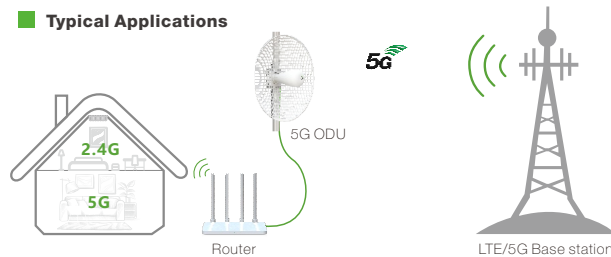
