### 3 Install the radio

#### Install the radio to a pole




**WARNING**  
Do not install the Feed Receiver into the reflector assembly by pushing down onto a tabletop or other flat surface as this can deform the panels. Hold the reflector assembly by hand.

### 4 Web configuration

- Check all wires are correctly connected.
- Configure the host system with static IP on the 192.168.1.x (x could be 10-254) subnet.
- Using a web browser access 192.168.1.1 (wait a few seconds after device power up).
- When login page appears enter "admin" in both the username and password fields.



### 5 Internet via 4G LTE

- Please insert the available Micro SIM card correctly. Use a network cable to connect the LAN port to PC.
- Power on the device and login to the device management Web-page.


#### Network Mode Change

Click the **LTE** and select **Network** to modify the network mode 4G or 3G or 2G. Default is **auto**.




#### Band Lock

Click the **LTE** and select **Network** to lock the Band. Please select a band supported by both the module and the SIM card. If not, you may not be able to connect to the carrier base station. It is better to check with your local operator.




#### APN Setting

Click **APN**, click **New Profile** to add **APN** configuration. Please confirm the specific **APN** configuration with the local operator.



#### Cell Lock

Click the **LTE** and select **Cell Lock** to lock the Cell. Please check the **earfcn** and **PCI** with your local operator. If input wrong value, you may not be able to connect to the carrier base station.
